The quotations will be opened on the same day at 3.30 PM in the presence of tenderers or their authorized representatives who may like to remain present at that time. The tender will be governed by the following terms and conditions:-

TERMS & CONDITIONS:

- 1. Contractor shall have to deposit Rs.10,000/- as EMD along with the quotation and subsequently SMD @ 5% of the total value of the contract which includes the already deposited EMD. The EMD & SMD must be deposited in the shape of Demand Draft drawn in favour 'ICAR UNIT CIRG' payable at Punjab National Bank, Farah (Code 4853).
- 2. All figures may be written clearly and cutting / over writings will not be accepted.
- 3. Penalty clause will be imposed @ 0.25% per month subject to a maximum of 2.5% of the total cost of work, if work is not completed within schedule time or mutually extended period. Extension of time may be granted to the contractor/agency beyond the agreed time of completion of the work taking into account the delay due to unavoidable circumstances.
- 4. Water and or Electricity charge will be deducted @ 1% flat of the total cost of the work, from the bill.

Fixing of Paver block 2.5 meters wide approx. (25 m) in front of the Car and Cycle stand

60 mm thick vibratory paver blocks should be used

Suitable protection to trees existing on both side of road may be provided

Total distance will be approx. 530 meters.

The fixing should be done on bed of lean cement concrete.
